



## **OFFICIAL Every Other Week Sunday Doubles League Rules**

Sunday's September 8<sup>th</sup> 2019 thru April 19<sup>th</sup> 2020

16 Week Season with Practice Starting at 6:30pm

16 WEEK SCHEDULE: Sept. 8, 22, Oct. 6, 20, Nov. 3, 17, Dec. 1, 15, Jan. 12, 26, Feb. 9, 23, March 8, 22, April 5, 19

***\*\*Please Fill Out Bowler Team Info Forms and Select a Team Name\*\****

1. Each Bowler shall pay \$20.00 per week for 16 weeks. If you miss a week, you still have to pay the full amount. You may Bowl-Out during the week before the upcoming league night. See Rule #3
2. This league is sanctioned with the USBC (bowl.com). There is a once a season sanction fee of \$22 per person (\$13 to USBC, \$9 to LakeShore Bowling Association). If you are sanctioned in another league this season in the LakeShore Bowling Association, then you do not have to pay again for this season. If you are sanctioned in another association, you would have to only pay \$9 local association fee.
3. Individuals or Teams may Bowl-Out if they can't make it to league. Pre-Bowls must be completed after the previous week, but before the league date you are bowling for. Post-Bowls are allowed in the case of an emergency and must be completed no later than 7 days after the date missed. Please notify the league secretary (Inman's Manager Shaun Ciesielski) so we hold off on running the weekly scores until the Post-Bowl is completed. You are only allowed to bowl out 7 times per person, per season. No Bowl Outs on Position Rounds or the Final Night.
4. Please bring your payment envelopes to the Front Desk by the end of the 1<sup>st</sup> game.
5. If you bowl, or have a sub bowl, \$20 must be paid that night. If you bowl-out, you ***DO NOT*** have to pay at the time of the bowlout. Just make up payment for the week(s) missed when you return the following week. If a team does fall behind, teams may be dropped from the league and the team will forfeit ALL Prizes and Money paid. Please notify management if there is a payment problem with a bowler on your team so we can try and resolve any problems. We will have payment updates every once in a while inside your payment envelopes.
6. All bowling fees should be paid in full by week 15 of 16 on April 5<sup>th</sup>. Week 15 will be the final week envelopes will be out to pay. This means the 16<sup>th</sup> week of bowling must be paid in advance by week 15, 2 weeks before the final night. This way we can have your prize money ready the final night. You can double up a week, or pay as much as you want at any time throughout the bowling season.
7. Handicap will be based on 95% of 225 of your entering average.
8. Entering Average is held for 1 week (3 games). Bowlers use their highest average from this league, going back 1 year. If a bowler has no prior average from this league from last season, then the highest USBC average shown on bowl.com from a League bowled at Inman's Bowling & Recreation Center will be used with 21 games or more. If no prior "Inman's" League average from last season, then bowlers will use their highest USBC average from the most recent season with 21 games or more going back a maximum 3 seasons. If a bowler has no USBC average from any of those seasons, then they establish an entering average after 3 games. There is NO team average limit or cap
9. 1 Bowler constitutes a Legal Lineup. Absent Bowlers -15 Per Game. If whole team is absent, opposing team will bowl their own team average minus 30 pins to win points.
10. 17 Points each week. 9 Team Points (2 Per Handicap Game, 2 for Handicap Series, and 1 Bonus for High Handicap Game on the Pair), 8 Individual Matchplay Points ( 1 Per Handicap Game Per Person & 1 for Handicap Series Per Person)
11. Please observe at least a 1 Lane Courtesy. When a bowler is up next to you, wait for them to bowl before you do.
12. On the final night, when all Bowling Fees are paid in full, each team will get their prize money.
